

PANASONIC BONUS LUMIX S5 45MM SIGMA LENS OR XLR ADAPTER PROMOTION

TERMS AND CONDITIONS

1. Instructions on how to claim form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer. By submitting a claim in this promotion, claimants acknowledge that they have read, understood and accepted these Terms and Conditions.
2. Promotion commences on 8.01am AEST on 3 September 2020 and ends at close of business AEST on 30 September 2020. The promotional dates are outlined below:
 - This Promotion is specific to the Panasonic Digital Still Camera Lumix S5 model number DC-S5KGN-K only ("**Participating Product**")
 - Purchasers must pre order the Participating Product from a Panasonic retailer.
 - Purchase period opens at 8.01am AEST on 3 September 2020 and ends at close of business AEST on 23 September 2020, ("**Purchase Period**") for pre orders for promotion model only.
 - Online claim form submissions, including proof of pre-order must be received between 8.01am AEST on 3 September 2020 and 11.59pm AEST on 30 September 2020, ("**Claim Period**").
 - You then need to finalise your claim after the product has been received by submitting your product serial number found on the body of the camera and your final tax invoice / purchase receipt showing that you have paid in full for the Participating Product to the participating retailer by no later than 11:59pm AEDST on the 15th October 2020 to finalise the claim, this must be received by 11.59pm AEDST 15 October 2020. ("**Claim Finalisation Period**").

Eligibility to Claim

3. Australian residents aged 18 years or over only are eligible to participate in this promotion.
4. Purchases for and in the name of a trust, a company (including distributors or retailers), a business (other than a sole trader) or on behalf of educational institutions, hospitals, fundraisers and government departments or organisations of a similar kind are not eligible to participate in the promotion. Lay-bys not paid in full by 15 October 2020 are excluded from this Promotion. Lay-by (i.e. not paid in full in the required time) and purchases from duty-free, discounted or clearance eBay sales, parallel import stores and second-hand purchases/retailers are excluded from this promotion.
5. To be eligible to claim, eligible claimants must::
 - (a), pre-order a Panasonic Lumix S5 Camera **Participating Product** from a participating retailer nationally ("**Qualifying Purchase**") during the "Purchase Period" and register the pre order claim online by 11.59pm AEST on 30 September 2020, and
 - (b) when the product has been received, must submit the product serial number found on the body of the camera and the final tax invoice / purchase receipt showing that the Participating Product has been paid in full from the participating retailer by the end of the "Claim Finalisation Period" being no later than 11:59pm AEDST on the 15th October 2020 to finalise the claim
6. Stock of the Participating Product at each participating retailer is subject to availability and it is the responsibility of the purchaser to check with each retailer that the Participating Product is available.

How to Claim

7. Claimants must submit their pre order claim online by visiting <https://au.panasonic.com.au/promotions>, clicking on the promotion tile on or before the end of the Claim Period at 11.59pm AEST on 30 September 2020, complete the online claim form, by inputting the requested details including but not limited to their full name, postal address, valid email address and purchase price of the Lumix S5 Participating Product, store of purchase, date of purchase, purchase receipt/tax invoice number, submitting the fully completed online form, and including, uploading a copy of their invoice/receipt for their pre order.
8. After receiving the actual Participating Product, a claimant must visit the link on their confirmation email then submit their final tax invoice showing that the Participating Product has been paid in full to the retailer together with the Participating Product serial number. For the purposes of verifying claims, the Promoter will require claimants to upload a copy of their original final purchase receipt/tax invoice to their online claim submission. Purchase receipts/tax invoices must show that the Participating Product is paid in full.
9. This Promotion is limited to online claims only. All information required to validate a claim for this Promotion must be submitted online. This Promotion doesn't contain a mail or e-mail option and any such claims received by mail or email will be deemed invalid.

10. Upon verification of the serial number and proof of payment by the Promoter, the Gift as specified in these terms and conditions will be awarded and dispatched within 12 weeks of the claim being finalised.

Gifts

11. Every valid claimant that is approved by the Promoter in accordance with these terms and conditions, can choose from either a Sigma 45mm F/2.8 DG DN Contemporary Lens, valued at \$999 RRP **OR** a Panasonic XLR Adapter, model number DMW-XLR1E, valued at \$699 (the "Gift").
12. If a claimant returns a Participating Product purchased for any reason other than a standard exchange for the same product, the claimant's claim will be rendered invalid, and if the claimant has already received the gift, the claimant will be required to return the gift, in full, to the Promoter at their own cost.

General Terms

13. The Promoter reserves the right, at any time, to verify the validity of claims and claimant's (including a claimant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these terms and conditions, tampered with the claim process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
14. Claim forms may be subject to follow up enquires or investigations or security and verification checks as the Promoter determines to apply in its absolute discretion. The claim form will be ineligible if it (and/or purchase receipt/tax invoice) is mutilated, illegible, stolen, forged, reconstructed, altered, incomplete or tampered with in any way, or if these documents fail any of the Promoter's security and verification checks.
15. Incomplete, indecipherable or illegible claims will be deemed invalid.
16. Only one (1) claim can be made per person. Multiple claims received from any person by the Promoter will be invalid.
17. Claimants must retain their original purchase receipt/tax invoice as proof of purchase. Failure to produce the proof of purchase when requested may, in the absolute discretion of the Promoter, result in invalidation and forfeiture of any right to a gift. The Purchase receipt/tax invoice must clearly specify the participating retailer where the Participating Product was purchased, purchase date (showing purchase was made during the Purchase Period and prior to submission of the online claim form), Panasonic product model number and purchase cost. If there is a dispute as to the identity of a claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the claimant.
18. The Promoter's decision is final, and no correspondence will be entered into.
19. Claims must be successfully verified by the Promoter before a Gift will be awarded. The value of the Gift is correct at the time of printing. The Promoter accepts no responsibility for any discrepancy in the Gift value.
20. The Promoter shall use all reasonable efforts to ensure that all approved claims will be fulfilled within twelve (12) weeks from the time the claim is validated. The Promoter accepts no responsibility should the delivery take longer than twelve (12) weeks for reasons beyond its reasonable control.
21. If for any reason a claimant does not take a gift at or by the time stipulated by the Promoter, then the gift will be forfeited.

If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any claimant; or (b) to modify, suspend, terminate or cancel the promotion, as appropriate.
28. Any cost associated with accessing the promotional website is the claimant's responsibility and is dependent on the internet service provider used.
29. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by a claimant; or (f) use of a gift.
31. The Promoter shall not be responsible for any delays in supply of the Gift to the claimant. The Promoter shall additionally not be responsible for any delays caused as a result of inbound transportation, disruptions (including but not limited to strikes, weather, postage delays, etc.) which are caused by events, which are beyond the control of the Promoter and/or the supplier of the Gift.
32. The Promoter reserves the right to extend the promotion without notice and at their discretion.
33. The Promoter collects personal information ("PI") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers and gift suppliers.
